

PONDERINGS - FEBRUARY 2019

In the last week of January I had the privilege of attending the Global Christian Leadership Summit in the somewhat warmer location of San Antonio, Texas. I won't deny it was a nice getaway from the dark and cold of the Alberta winter. It's nice to smell vegetation and go for a walk without a jacket. Cacti, palm trees, southern barbecue, full tank of gas for just over \$20 US, open carry weapons laws—what's not to like?

Learning did happen, however. One session, led by the director of the American Bible society, presented the challenges to 21st century Christians in connecting with Scripture. This gentleman expressed his conviction that believers are no longer able to read and concentrate for sufficiently long periods of time that are required to make sense of extended and complex passages. He didn't isolate a single factor as being solely to blame for this trend, but did identify a primary culprit—digital technology in the form of the cell phone.

Psychologists, doctors, educators and astute observers of workplace culture are increasingly concerned about negative behaviours associated with high levels of exposure to cell phones and "screen time", such as:

- General distraction and social disengagement
- Anxiety and depression
- Sleep disruption
- Increased rates of suicide

In the area of neurology, credible students are revealing that high levels of exposure to digital technology appear to be actually rewiring the brain in ways that reduce capacity to respond to the immediate environment, and particularly so in younger individuals. We have had the opportunity to observe some of the negative effects of cell phones firsthand at school for quite some time. Some students arrive at school sleep deprived, and use their phones for gaming and social media interaction at every opportunity. Smartphone users receive updates on their screen time weekly (I log about 1.5 hours). Some students report usage of six hours **per day**. The use of phones for forays into the more unsavoury areas of the web undoubtedly constitutes a certain percentage of phone use. For these reasons we have recently

enacted measures to discourage students from using them during class time.

Christians need to be discerning in all things, and I would ask parents in particular to give serious thought to your child's use of their cell phone. Together we need to be vigilant and responsible in the manner that we manage this pervasive digital presence.

Bill 24 Court Case - Encouraging Update from ARPA Canada

The ARPA Canada team is so grateful to witness how faithful and active you have been in response to the challenges your schools have received from the Alberta provincial government.

2019 began with some very encouraging news on this file. On Tuesday, January 8th, ARPA Canada was granted intervenor status in the court challenge to Bill 24, a bill which mandates unacceptable changes to school policies, imposing the secular humanist worldview on our schools and families.

We praise the Lord for the court's decision to not only grant us intervenor status, but to also give the added (and very rare!) privilege of presenting our own evidence in this case. Typically, a court intervention allows a third party to bring their perspective to the judge in the form of written, and sometimes oral arguments. What's really special is the judge presiding over this case also gave ARPA special permission to present affidavit evidence to the court, in order to develop a case study of the effect of the law on the Reformed Christian community. We are thankful that, in addition to the parental rights argument and general constitutional arguments brought forward by the Justice Centre for Constitutional Freedoms, we now have the opportunity to present a distinctly Reformed argument for why the changes brought about by Bill 24 are unconstitutional and should be done away with.

In the court hearing that considered our request, André Schutten, ARPA's Director of Law and Policy, explained who the Reformed Christian community is, and how the legislation affects this community which has a unity of purpose between home, church, and school. He highlighted the fact that independent education is a hallmark of the Reformed Christian community. He noted the importance of parental authority and responsibility and that the state cannot replace parents in the education of their children. He went on to explain that the legislation goes right to the heart of the existence of our schools. While the love and support for all students will look different than the approach preferred by the education minister, different approaches to protecting and supporting students should be accommodated. That's what the constitutional guarantee of religious freedom requires of the Alberta Minister of Education.

We praise and thank God for this opportunity and join you in praying that God will bless these efforts. And we thank all those of you who have financially supported our work to make it possible.

So, be encouraged dear reader! Our schools are being well represented in the courts – by the JCCF articulating a passionate defense of the broad principles of parental rights and constitutional freedoms for all religious schools, and by ARPA Canada, tabling evidence of the distinct commitments and qualities of the Reformed faith, and how we can achieve the honourable goals of safe and welcoming schools for all of our children, but in a way that does not compromise on the Truth of Scripture.

ACCOUNTABILITY PILLAR SURVEYS

As an annual check-up on the education system, the Accountability Pillar provides an opportunity for Alberta Education and school authorities to ensure that we are equipping students for success. You have already received a copy of the survey.

The Accountability Pillar uses a set of 16 indicators. Data on these indicators consists of surveys of students, parents, and teachers on various aspects of education quality, student outcomes such as dropout and high school completion rates, and provincial assessments of student learning.

All surveys are anonymous and ask questions about experiences with your school


Your participation in the survey helps provide important information on the quality of education your child is receiving, so we encourage you to return your survey promptly. The deadline for on line submission of these surveys has been extended to March 8.

Survey results will be available to school authorities in May, and will be reported publicly as part of their 3-Year Education Plans.


